



PAVER SUPPORTS LIMITED WARRANTY

Archatrak Inc. warrants that adjustable paver supports sold by us under the brand name "Eterno" will remain free from defects for a period of three (3) year from date of purchase.

If any manufacturing defect should become evident within the specified warranty period, Archatrak will replace the defective paver support(s) free of charge.

Archatrak shall not be responsible for labor charges incurred for installing replacement paver supports and such charges are excluded from this warranty. Archatrak will also not be responsible if any pedestal support is installed with a visible manufacturing defect.

Because specific installation details, structural design and environmental conditions are beyond our control, no responsibility can be accepted due to:

- I. Abnormal stress imposed on the pedestal supports within ordinary use or in situations that do not comply with commonly accepted use of the pedestal supports.
- II. Installation of the pedestal supports in locations or for purposes that are deemed to be unsuitable by us.
- III. Defacing caused by foreign objects or materials.
- IV. Damages resulting from improper installation or workmanship not in accordance with Archatrak's instructions or standard industry practice.

This warranty is a limited warranty and shall constitute the full extent of Archatrak's liability on its warranty. This warranty is in place of all other warranties, expressed or implied, including the implied warranty of merchantability and the implied warranty of fitness for a particular purpose.

To make claim under this warranty, Archatrak must receive notification of the claim as soon as reasonably possible, but in no event later than one year after the pavers have been installed.
