### Release of Liability

Resident, desires to obtain a volunteer automobile transportation through Grand Driver, Inc. dba Safe Solutions, a Georgia non-profit corporation, and accordingly executes this release of liability (this "release"). In

consideration of the services performed by an affiliate, which is best determined by Grand Driver, Inc., dba Safe Solutions the volunteer as rider hereby freely voluntarily executes this release under the terms below. I/We understand that Grand Driver, Inc., dba Safe Solutions will determine whether this service is "curb to curb" only, if additional arrangements are identified as "needed" the volunteer as rider may incur additional cost for transportation.

***Release.*** Volunteer as rider does hereby release, discharge and covenant not to sue Grand Driver Inc., dba Safe Solutions its members, officers, directors, employees, volunteer agents, successors, and assigns (collectively the "organization") from and against, or with respect to any all liability, claims or demands that arise or may hereafter arise directly or indirectly from the transportation service (the "services") recommended and provided by the organization. The foregoing release includes but is not limited to any and all liability or claim that the volunteer as rider may have against the organization with respect to bodily injury, personal injury, illness, death, or property damage or loss that may result, directly or indirectly from the services.

***2. Waiver of Rights; Legally Binding.*** Volunteer as rider understand that by executing this release he/she/they are waiving legal rights including the right to sue, and intends to be legally bound by this release.
