TRADING TERMS

PRICING

All deliveries will be at wholesale price unless otherwise stated. However all prices are subject to change without notice. All wholesale prices include excise duty where applicable but exclude the government Wine Equalisation Tax and GST. Wine Equalisation Tax will be charged where applicable. In all cases GST will be charged on the final Net Invoice price, after the WET, if applicable

TERMS

Payment will be strictly cash on delivery or for approved credit holders, "goods purchased in one month are due for payment in full by the last Friday of the following month." Payment in full means payment of all invoices for goods purchased in one month. No customer may deduct monies owed to them by The Wine Crowd Pty Ltd, (hereafter referred to as "TWC"), without approval in writing from a Managing Director. TWC reserves the right to withhold further deliveries if the customer does not adhere to our payment terms. Accounts paid by credit card will incur a merchant fee which will be passed on at cost. Credit facilities on overdue accounts may be withdrawn or varied at the discretion of TWC without notice to the purchaser. TWC reserves the right to charge interest on all monies owing by a purchaser that are outside these terms. The purchaser also agrees to reimburse TWC for any legal expenses incurred in the collection of overdue monies.

CLAIMS PROCEDURE

Any claims of whatever nature must be reported to TWC within 7 days after receipt of goods or the purchaser is deemed to forfeit any claims for damages or set off against TWC. Please quote invoice number, account name, delivery address and date of delivery as well as all other details pertinent to your claim, without exception.

CLAIMS LIABILITY

Subject only to the provisions of the Trade Practices Act which necessarily apply to the contract and cannot be excluded, all other implied terms, conditions and warranties are hereby expressly excluded and TWC's liability is limited to:

The cost of replacing the goods; OR
The cost of obtaining equivalent goods.
whichever is the lower amount

RETENTION OF PROPERTY

All goods delivered by TWC remain the property of TWC and the Title in any goods does not pass to the purchaser until all debts owed to TWC on any account whatsoever, including interest, Bank charges, Legal Fees and collection expenses are paid in full to TWC. In this regard the Purchaser grants the right to TWC to enter the Purchaser's premises or any other premises where the goods are reasonably believed to be stored, without notice, to take possession of the goods. Notwithstanding the foregoing, it is agreed that the goods are at the entire risk of the purchaser from the time of delivery

ULLAGES

TWC will accept faulty stock (including label damage, dry breaks, leakers or short fills etc) for replacement only if seals on bottles and casks are still intact and date not expired. Damaged stock found after delivery must be returned in the original carton for replacement. Restaurant returns are only acceptable if product is out of condition. In all cases stock must be viewed and returned through TWC area managers. Supply invoice number and delivery date must be provided in order to action replacement or credit. No replacement or credit will be forthcoming on stock broken or damaged on The Purchaser's premises.

RETURN OF STOCK

A TWC Sales Representative or manager must view stock offered for return for whatever reason. Invoice number and delivery date must be quoted, before any returns will be accepted for credit and authorisation is required from the Sales Manager.
