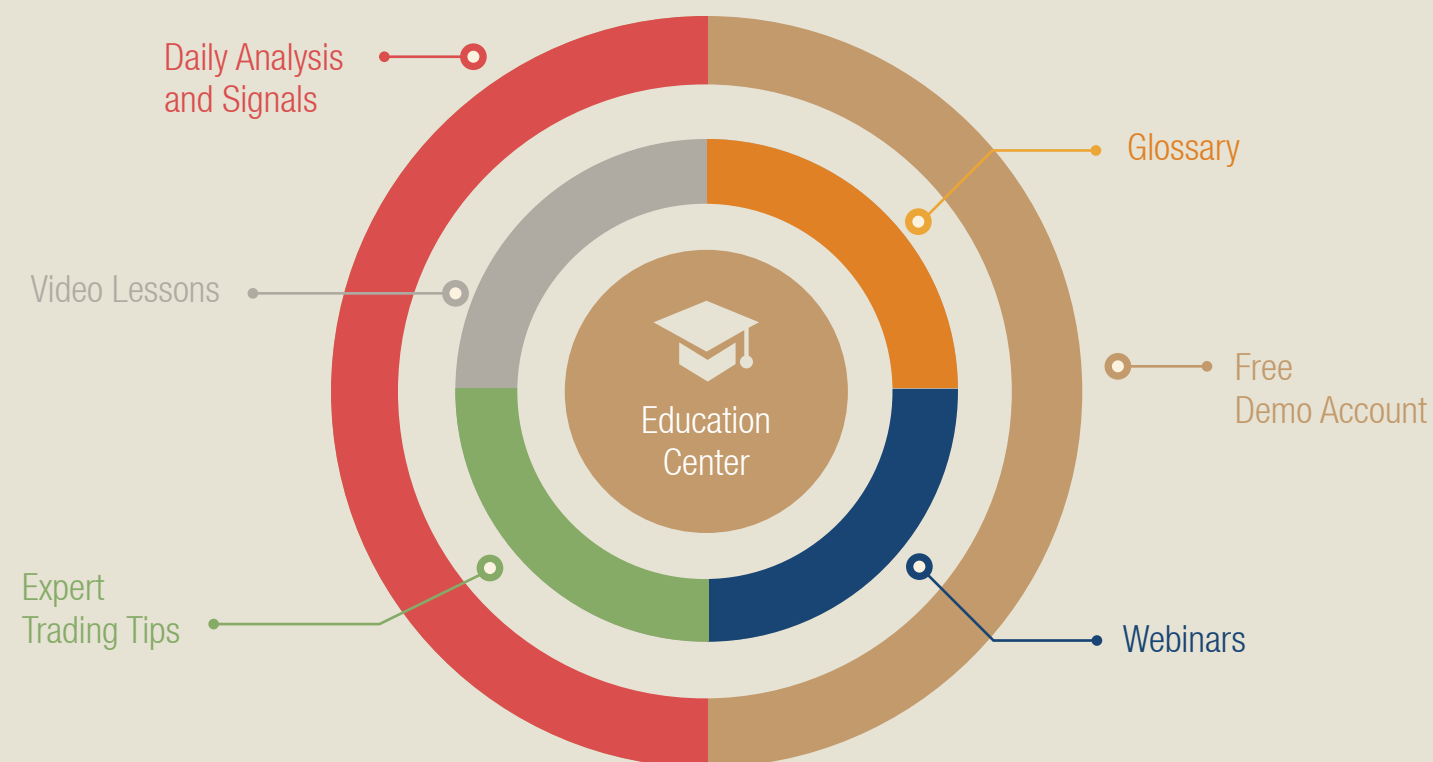

Since 2001 the Financial Services Authority (FSA) has been responsible for monitoring brokerage companies and is the authority which grants licenses to Forex trading firms to call themselves FSA registered brokers.

FSC Regulation No. 097392

The FSC was established in 2001 and operates within a modern and internationally recognised legal framework which includes the Financial Services Act, the Securities Act and the Insurance Act. The Financial Services Commission, Mauritius (FSC) is the integrated regulator for the financial services sector other than banking, and global business.

ASIC Regulation No. 398528

The Australian Securities and Investments Commission (ASIC) began operating in 1991 as the Australian Securities Commission (ASC) replacing the National Companies and Securities Commission (NCSC) and the Corporate Affairs offices of the states and territories.
